

TERMS & CONDITIONS

1. These are the terms and conditions (hereinafter referred as "Terms") subject to which the "Tigojis" activity (hereinafter referred as "Activity") is being organized by Aircel Limited having its registered office at 5th Floor, Spencer Plaza, 769 Anna Salai, Chennai – 600 002 and users participation in the Activity is subject only to the acceptance of the Terms mentioned herein. If a user does not want to be bound by the Terms hereinafter appearing they are requested to refrain from entering the Activity. All queries must be addressed to Aircel's above address.
2. To celebrate World Tiger Day, Aircel has created a set of Tiger themed mobile stickers that are available for free download on Google Play and iOS. These stickers referred to as 'Tigojis'.
3. To participate in the Activity one can:
 - a. Download Tigoji sticker from the iOS or Google Play store and can share the stickers across various platforms.
 - b. On Facebook, a user ("Participant") can participate in the "Pic badge" activity by putting the Tigoji SOT badge as their profile picture. The Activity requires the Participants to sign in and put the pic badge of his/her choice as their profile picture.
4. The ways of participation mention in 2(a) and 2(b) above are open only to the citizens of India and should be above 18 years of age on the date of this Participation. This shall be governed and enforced in accordance with the laws of India and the Courts in New Delhi having exclusive jurisdiction. Aircel is a telecom services organization which has no monetary gain or interest in this Activity, except promoting the culture and interest in saving the tiger population in India.
5. Aircel shall evaluate all submissions for the purposes of this Activity, including verification and as specified in these terms and conditions.

This document is an electronic record in terms of the Information Technology Act, 2000 and the amended provisions thereon, pertaining to electronic records in various statutes as amended by the Information Technology Act, 2000. This electronic record is generated by a computer system and does not require any physical or digital signatures.
7. These terms and conditions contained herein govern the terms of participation in this activity. Participants entering the said activity shall be deemed to have accepted these terms and conditions.

8. This is a limited period Activity, which would start on 24th July 2015 at 00:00:01 hours and end on 30th September 2015 at 23:59:59 hours ("Tenure of Activity"). Aircel may at its absolute discretion curtail or extend the Activity Period, as it deems necessary.
9. For every Tigoji app downloaded or a pic badge shared by a Facebook fan, Aircel will pledge Re.1 towards Tiger conservation.
10. The total contribution by Aircel towards this Activity will be based on the number of pic badges shared, and the number of APP downloads, capped at a maximum of INR 10,00,000 (Rupees Ten Lakhs Only).
11. The contribution amount shall be donated by Aircel before March 2016, to a Non-Governmental Organization ("NGO") working for / support the cause of tiger conservation in India.
12. There are no prizes or incentives for Participants involved in this Activity.
13. The decision of Aircel with respect to the Activity and the Terms & Conditions hereto shall be final and binding on all the Participant(s) and no communication shall be entertained in this regard at any time.

Aircel shall not be liable for any loss, claim, action, damage or cancellation of this Activity caused by events beyond their reasonable control including computer malware, technological bugs and viruses, network and technical failures, phishing, unauthorized war, natural calamities, floods, etc. Aircel shall not be liable for any consequences of Participant error including (without limitation) providing incorrect contact details & identity proof.
15. Aircel withholds the right to update/ modify or amend these Terms and Conditions as per its discretion during or after the Activity, without any prior notice, in its sole and absolute discretion. These Terms & Conditions constitute the comprehensive terms and conditions of the Activity and all participants are bound to comply with the guidelines, requirements etc. contained herein. No communications/correspondences will be entertained by Aircel in this regard. All rights and information including noticeable personal information arising out of this Participation shall be owned by Aircel. Aircel shall hold all such intellectual property rights arising in this Activity.
